SCHOOL VACATION TRAVEL REMINDERS:

Any staff member or student who travels out of state is subject to the [Massachusetts' COVID-19 Travel Advisory](#) and should quarantine for 10 days upon their return to Massachusetts. Travelers in the following categories are exempt from the 10-day quarantine if:

- The traveler has received a negative COVID-19 result on a test administered no more than 72 hours prior to their arrival in Massachusetts, or receives a negative COVID-19 test result after their arrival in Massachusetts. Travelers who test after their return to Massachusetts should quarantine until they receive their result.
- Any traveler who is returning to Massachusetts after being out of state for less than 24 hours.
- Travelers who are fully vaccinated (i.e. who have received two doses of either the Moderna or Pfizer vaccines, OR who have received a single dose of the Johnson & Johnson vaccine, 14 or more days ago) and who do not have symptoms.
- Tri-Town Public School Staff or Students who travel out of state must either provide documentation of a negative test result, completed vaccination or will need to quarantine for the 10-day period before they will be allowed to return to work/school.

MIDDLETON FIRST RESPONDERS

As the their title fits their actions, First Responders are the individuals who "First" respond to incidents, requests for assistance, and unknown situations. From the beginning of the pandemic, the Tri-Town First Responders have been great in their response to the community: From the initial first Local Emergency Planning Committee (LEPC) meeting with the Health Department and other municipal and local departments to collaborate on a response to a virus, at a time of which we knew not much about; To being the "First" on scene to transport COVID suspect patients to the hospitals while also navigating their own personal by donning knew Personal Protective Equipment (PPE) to ensure they did not contract the disease individually or transmit it to others such as their work colleagues or family members.

First Responders continue to work weekly with Public Health Officials in services to individuals/families with COVID, in areas such as but not limited to, help with medical transport, welfare checks, and vaccination clinics.

Additionally, officers at the the correctional facility continue efforts to control the spread of the disease in an environment where cases can grow and spread quickly.
